## 5431 Place Lake Dr.

Application to replace existing hedges in front flower bed. Place palms and other plants per attached. (Drawing included in application) Contractor: Arellano Lawn Care Maintenance.

Application to remove one laurel oak tree from front yard and one diseased live oak from back yard. County Permit No. 20200333 attached. Removal must include stump grinding below grade and installation of sod. Contractor: Arellano Lawn Care Maintenance.

## 5733 Sterling Lake Dr.

Application to replace all unattractive plants with color and life. Replacements will include pygmy date palm, petra croton and trinette variegated schefflera. Photos with notes attached. Homeowner doing the work. NOTE: Modification(s) to any part of this Conditional Approval must first be approved by the ACB This application is conditionally APPROVED as presented.

## 5742 Sterling Lake Dr. (in response to a violation letter)

Owner has marked three colors in a catalog from Boral they believe will closely match existing tiles. Colors marked are Bay Side Blend, Navajo Sand Blend and Tequila Sunset. Also, Boral sent six tile samples to homeowner for our review. However, only Tequila Sunset was included in those samples, all other samples were Boral's choice. Tequila Sunset is not a close match to existing tile color. ACB requires additional information and samples of Bay Side Blend \& Navajo Sand Blend.

ACB requires clarification of what is a $1 / 2$ Mansard Roof.
